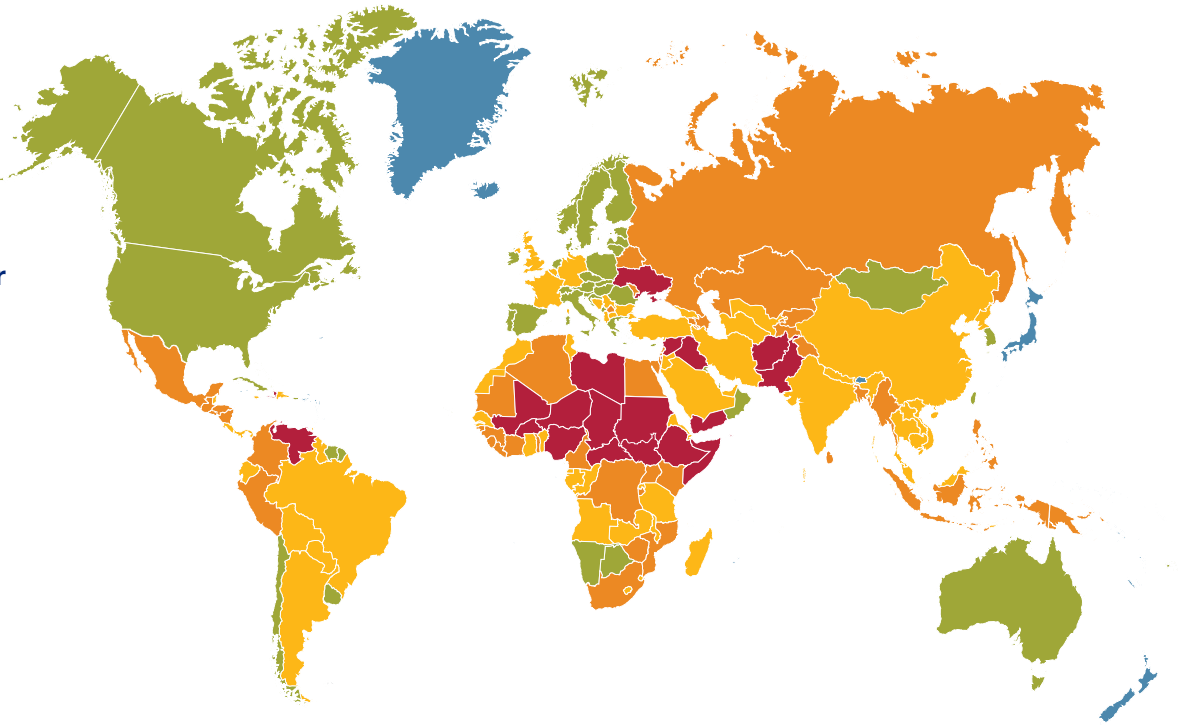

Determining factors for security threat levels:

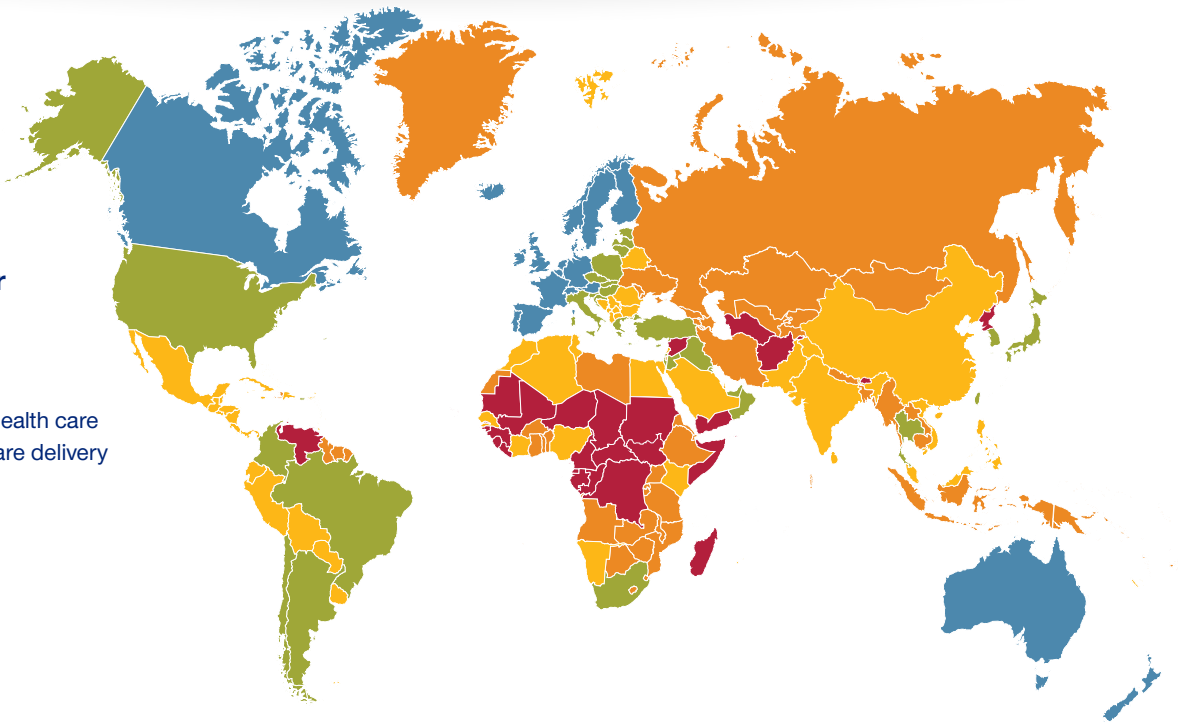
- Armed Conflict
